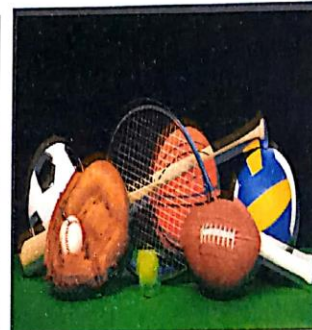

Undertaking by the Student

The college administration has the right to fine, suspend, rusticate, relegate or terminate the studentship of the student if found guilty:

1. Cheating, stealing, immoral conduct or misbehavior, smoking inside building and using mobile inside class rooms.
2. Willfully and deliberately damaging or misusing the college property.
3. Rudeness to member of the teaching and administrative staff.
4. Violating the rules and regulations of the college or the instructions given to the students from time to time.
5. Use of drugs or carrying of weapons/fire arms.
6. Providing wrong information in the application form at the time of admission.
7. Inciting, inducing, pressurizing other students or indulging in politics.
8. A student who himself absent from the class without proper sanction for the continuous period of 14 days shall automatically stand withdrawn from the college rolls.
9. Dues once paid are not refundable, and shall be increased minimum 10% annually.
10. Heavy fine shall be imposed in installment not paid on due time.
11. Concession is not a matter of right rather privilege but is subject to 75% Attendance.
12. Total failure in any university exam & non-appearance in exams will not entitle any further concession.
13. Following fee schedule shall be strictly adhered:
14. Half of the fee to be deposited at the time of admission remaining will be divided in equal installment.
